

## **RAA Charge x Monarto Safari Park Competition**

## **Competition details**

In partnership with Monarto Safari park, RAA will be giving away 10 family Safari Park passes valued at \$115 to 10 lucky winners. To be in the running, simply take a selfie of yourself charging your EV using the RAA Charge network, and post it on social media, tagging @RAAofSA and @MonartoSafari.

The promotion is open from 29 June to 30 August 2023, or until the 10 passes are redeemed – whichever comes first.

## **Terms and Conditions**

- 1. Information on how to enter and prize details form a part of the competition terms and conditions of entry (**Terms and Conditions**).
- 2. Entry into this **RAA Charge x Monarto Safari Park** competition (**Competition**) is deemed acceptance of the Terms and Conditions.
- 3. The Promoter is Royal Automobile Association of South Australia Incorporated, of 101 Richmond Road, Mile End SA 5031, ABN 90 020 001 807 and available by phone on (08) 8202 4600 (**Promotor**).
- 4. All employees and their immediate families of the Promoter, and its related bodies corporate are ineligible to enter. Immediate family means any of the following: spouse, de facto spouse, child or step child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, brother, sister, step-brother or step-sister.
- 5. The Competition commences at 11:00am ACST on 29 June 2023 and closes at 5:00pm ACST on 30 August 2023 (**Promotion Period**).

To be eligible to enter the Competition, entrants must take a selfie (photo) of themselves charging their EV using the RAA Charge network and post it on social media tagging @RAAofSA and @MonartoSafari during the Promotion Period; must be 18 years of age and over; and be a resident of Australia.

- 6. Only one valid entry per person.
- 7. Entries must be submitted as a social media post, published on Facebook or Instagram.
- 8. Entries not completed in accordance with these Terms and Conditions or received after the Promotion Period ends will not be considered. Incomplete,



- fraudulent or incomprehensible entries will be disregarded. The Promoter accepts no responsibility for late, lost or misdirected entries.
- 9. The Promoter collects personal information from each entrant in order to conduct the prize draw. Entry into the Competition is conditional on the person providing their name, phone number, and email address.
- 10. - 3. The ticket is valid for 2 adults and 2 children (14 and under)
- 4. All children under 16 must be accompanied by a paying and supervising adult.
- 5. The ticket is valid for a single day entry to at Monarto Safari Park for 2 adults and 2 children (as described above).
- 6. Unauthorized sale or duplication of the ticket may result in you being denied admittance to the venue. The Society is not responsible for any inconvenience caused by unauthorised sale or duplication. In the event that duplicate copies of the ticket are presented at the gate, The Society reserves the right to deny entry to all parties.
- 7. Upon entry to the venue your ticket will be scanned.
- 8. No refunds or exchanges will be available except as provided in the seller's conditions. Any service charge is non refundable. The seller is not required to give a refund when the ticket holder chooses not to attend
- 9. The Society has the right to refuse entry or evict patrons who behave in a manner that is inappropriate, offensive to others, or illegal.
- 10. Due to strict quarantine rules, visitors are not permitted to bring animals on our sites. This is inclusive of assistance animals
- 11. Footwear must be worn while moving about the park grounds
- 12. Monarto Safari Park is a smoke-free and vape-free site
- 13. Sound and video recording may not be permitted based on the activities being undertaken within the venue (i.e. unauthorized filming/photography for commercial purposes). - 14. The Society reserves the right to vary the advertised activities and/or exhibits.
- 15. Balloons, straws, scooters and bikes are not permitted into park grounds
- 16. Information regarding Keeper Talks are available from the Monarto Safari Park website, or on the map handout available upon arrival.
- 17. All Keeper Talks are subject to animal management and may be cancelled without notice.
